Alongwith Campus Manager, Deputy Registrar, Assistant Registrar & Representative, Procurement Cell of YASHADA were present.

- At the outset all were welcomed, and asked them to pose their queries, which would be uploaded on our website.
- Siddhivinayak Enterprises representative asked whether five crore turnover was specifically for Conservancy Contract. Campus Manager replied since the tender is for Conservancy the turnover is specifically for the same.
- 3. CISB Facility Services, Pune representative asked whether MSME registered firms were exempted from EMD, to which Procurement representative Shri Katakdhond replied that such exemption is applicable, temporarily due to technical reasons, the agency will pay the EMD amount and the same will be refunded after completion of tender process.
- Siddhivinayak representative asked that if two bidders qualify as L-I what would be the
 deciding factor for award of Contract, Campus Manager replied the award of Contract
 would be decided on Merits by YASHADA.
- 5. Siddhivinayak representative asked if anybody quotes Zero as Service Charge what would be the decision taken, Campus Manager replied no agency can survive without Service Charge, and statutory payments proof is strictly sought by YASHADA, and nobody can do business with zero Service Charge, the same bidder shall disqualified.
- Siddhivinayak representative asked bill payment period, Campus Manager replied that the bill payment will be processed immediately subject to full statutory payment, proof of salary disbursement through bank is submitted alongwith bill as per Tender clause 5.0

- Siddhivinayak representative asked as per Page 15 of Tender (B) Statutory Compliance Ceiling of Rs. 15000/- for deduction of Provident Fund & Ceiling of Rs. 21000/- for deduction of ESI is mandatory, Campus Manager replied that this ceiling is as per existing laws and would be mandatory.
- 8. Siddhivinayak representative asked Supervisor will qualify as skilled or highly skilled category, Campus manager replied that Supervisor will be treated as skilled category.
- 9. Siddhivinayak representative asked whether cost of Tender Form is refundable, Campus Manager replied that cost of Tender Form is not refundable.
- 10. CISB Facility Services, Pune representative asked whether rates to be quoted are as per Central Government rates or State Government rates, Campus Manager replied that the minimum wages applicable as per Maharashtra State Government orders could be strictly applicable.
